GovernmenthaveacceptedtheaboverecommendationoftheTenth PayRevision Commission.Accordingly,it ishereby orderedthattheDearnessAllowancetotheStateGovernment employeesshallbe regulated@0.524% foreveryonepercentofDearness Allowance sanctionedtothe employeesof Government of India with effectfrom01.01.2014. The Dearness Allowance sanctioned inthe Revised PayScales,2010intheG.Os.,2nd and 4threadaboveshallberegulatedintheRevisedPayScales,2015asunder:
